If you are a food vendor NOT currently permitted in Sacramento County you are considered a **Temporary Food Facility (TFF) and will incur an additional TFF Fee which MUST be included with your application and is not a part of the booth fee.** The Fee is \$75 for Low-Risk (includes pre-packaged foods, hot dogs, corn dogs, popcorn, cotton candy, Shave Ice and non- dairy coffee) and \$158 for High-Risk foods (includes food that is cooked, barbecued, or deep fried, nachos, meat or seafood, rice, pizza, sushi, tacos, and dairy drinks).

- Please bring your own set up equipment and tent weights in case of wind. This event is rain or shine.
- Side street parking will be available, but no street parking will be allowed where the festival will be held.
- Please do not tear down before 8:00 pm. Tear down may take place between 8:00 pm & 9:00 pm.
- You will not be permitted to bring in your vehicle to load until 8:00 pm.
- Please pick up your area before you leave. If you brought it, take it home. Please do not stuff event trash cans with your trash.
