**Public Meeting and Request for Proposals
for 2011 Community Development Block Grant
(CDBG) Funds**

The City of Citrus Heights is soliciting proposals for eligible housing and community development activities for its 2011 CDBG funds. Selected proposals will be included in the City's 2011 Action Plan, which serves as an application to the U.S. Department of Housing and Urban Development (HUD) for CDBG funding.

The uses of CDBG funds may include the improvement and preservation of existing housing, the construction and improvement of public facilities and infrastructure, furthering economic development, the provision of public services, youth services, neighborhood revitalization, and the general planning and administration of the CDBG program. **The 2011 CDBG application must be received at Citrus Heights City Hall, 6237 Fountain Square Drive no later than 5:00 p.m. on Friday, August 20, 2010.**

August 3, 2010	Funding Application Workshop at 3:00 p.m., Trellis Hall, Citrus Heights, City Hall.
August 20, 2010	2011 CDBG applications due by 5:00 p.m. to Citrus Heights, City Hall.
September 23, 2010	City Council Meeting – draft annual Action Plan considered, preliminary allocation of funds.
September 28, 2010 – October 28, 2010	Annual Action Plan public comment period.
October 28, 2010	City Council Meeting – final annual Action Plan adoption and final allocation of funds.
November 12, 2010	Adopted annual Action Plan is submitted to HUD.

The public is invited to comment on the use of CDBG funds by speaking at the scheduled meetings and in writing at any time during the planning process. Comments will be accepted until final City Council action on October 28, 2010. All comments will receive a response from the City. Comments received by October 28, 2010 will have the City's response included in the annual submission to HUD. Draft documents will be made available concurrently with the agenda of the scheduled City Council meetings.

Draft program documents will be available for review at the public counter of City Hall, 6237 Fountain Square Drive and at www.citrusheights.net. Navigate to City Services >Housing and Grants >Community Development Block Grant.
